PUBLIC SESSION.

Mr Bridgewater spoke about his concerns regarding traffic and parking along Liskeard Road, having already raised the matter some time ago. Cllr Smith responded explaining the procedure with the TRO (Traffic Regulation Order). Cllr Gist also referred to other areas in the town that are experiencing traffic issues, namely near the fire station.

Mr Green discussed the East/West bypass route, the state of grass verges along Southern Road, rusty signposts and the flowerbed at Saltash Road roundabout. Being the main tourist route in the town he felt that the area should be more presentable to encourage people into the town. Cllr Smith agreed to take the comments to the Outside Services committee for consideration. Cllr Denley confirmed that many of the bushes along that road were maintained by the former Britain in Bloom committee and the Town Forum are responsible for said flower bed. Cllr Mrs Coakley has a Town Forum meeting tomorrow and will discuss the flower bed matter then.

A discussion then followed on the new parking meters and the non-transferable tickets.

b) Cllr Smith and the Clerk have met with GP Strategies, a skills training academy. There are potentially a few courses that may be of interest and these would be explored further.

c) The raffle for the Neighbourhood Plan questionnaire would be held after the meeting and followed up with a press release.
