MAINTENANCE & WORK PRIORITIES

7. FOR DECISION – Staff (GdP) to give an update on any current issues

The focus this month has been to review the rota system. There is a request for some tree specialist works in Saltash Road Recreational Field to be undertaken, which could benefit the CCTV coverage in that area.

Resolved. It was proposed by Cllr Gist seconded by Cllr Denley and agreed that the Chair & Vice meet with staff (GdP) and agree the works required (to meet at the Park 11am on 8th Sept)

Coordinating a date with everyone had not been successful and the consensus was to schedule a date in the Spring.

11. ANY OTHER BUSINESS – At the discretion of the Chairman

a) There is a proposal that Fore Street flower tubs would benefit from replanting prior to Honey Fair.

Resolved. It was proposed by Cllr Gist seconded by Cllr Mrs Gold and agreed to proceed with the purchase of some dwarf daffodils and winter flowering pansies for the flower tubs in Fore Street and on St Mary's Close, without any commercial involvement/sponsorship. These would be planted in time for Honey Fair, allowing space for

the Rotary crocuses, which are being planted in the same tubs during November.

- b) Cllr Tagg asked for an update on the CCTV camera in Saltash Road Park. The Clerk explained that there is currently an interim camera in position and we await confirmation as to whether the poles are to be heightened.
- c) Cllr Gist explained that pending improvements to the electricity box at Saltash Road Recreational Field.
