#### 5. PLANNING APPLICATIONS

**a) PA17/09114, 38 Liskeard Road, Callington.** Change of use of derelict former Chapel building into four self-contained flats and maisonettes, Parsons

**Resolved.** It was proposed by Cllr Dowdall seconded by Cllr Tagg and agreed (8 Support, 0 Against and 1 Abstention) to have no objection to the application subject to consultation with the neighbours and the use of materials that are in keeping with the building.

**b) PA17/08999, Glendale, 114 Launceston Road.** First floor extension over previous addition, Farris

**Resolved.** It was proposed by Cllr Dowdall seconded by Cllr Coakley and agreed unanimously to have no objection to the application, subject to consultation with the neighbours and the use of appropriate materials.
